Terms and Conditions and Entry

1. Eligibility and Entry

- Entry for the awards is free of charge and no purchase is necessary for exhibitors of Fi Europe 2021.

- Deadline for any submissions to the Fi Europe Innovation Awards 2021 is **6 October 2021**

 category winners will also be promoted on the Fi Europe website. The
 prize is non-exchangeable, non-transferable and no cash alternative is

- Shortlisted finalist candidates will be notified by email (using details provided at entry). If a shortlisted candidate does not respond to the Promoter within 24 hours of being notified by the Promoter, then the

candidate may be removed from the shortlist and the Promoter will be entitled to shortlist another candidate in accordance with the process described above.

- All finalist candidates selected are required to present their entry to the jury in live pitches. The presentation must last no more than 15 minutes. These jury presentations will take place either online at a mutually agreed date, or in-person in Frankfurt Germany on 29th November 2021.
- The Fi Europe Innovation Awards ceremony will be presented online during Fi Europe Online 2021, co-located with Hi Europe.
- The decision of the jury is final and irrevocable, and no correspondencewill be entered into in respect of the decision of the jury.
- Entry to the Fi Europe Innovation Awards 2021 is not open to any employees of the Promoter, their families, agents or any third party directly associated with the administration of the awards.

2. Conduct of the Awards

- The Promoter will treat all material in the strictest of confidence, in accordance with applicable data protection laws. The content of each entry will remain sealed from the public apart from the 50-100 word synopsis for external use. The synopsis for external use is the only material that will be made publicly available.

- Only the short-listed proposals for each category will be announced.
